Vi-Pro® Window Tape Vario

Product description:

Vi-Pro® Window Tape Vario is a tape that secures the filling of the gap between the joinery and the walls in certain circumstances. The tape can be used both inside and outside the partition.

Advantages:

- The back of the tape is fully covered by a high-quality adhesive, which guarantees a tight connection to the most popular construction materials.
- The adhesive is protected by silicone-coated film with finger lift, which facilitates peeling off the liner.
- The product in PLATINUM+ version is equipped with an additional self-adhesive strip on the top side, which is meant for application to the window or door frame.
- The structure of the surface tape facilitates plastering and optimizes the adhesion of cement based adhesives.
- The product is odorless and does not contain VOC and hazardous substances.

Application:

The tape is intended for sealing the gap between a window or door and a wall on the outside and on the inside.

Storage:

Store in dry place at +1°C to +25°C, in an original packaging for 24 months.

Application instruction:

The surface to which the tape is going to be applied should be dry, degreased and free of dirt. The product can be used at -10°C only when conditioned at around 15 °C to 20 °C at least 2 hours. Unwind the product from the roll and apply it to one side of the joint. Cut to the required length, peel off the protective film, then press it to the other side of the joint. Window joinery processing should be completed up to 3 months after installing the tape or protected against direct sunlight.

Waste handling:

The raw materials and the product itself are not classified as dangerous substances. The remains of the tapes and the disassembly material is plastic waste. Treat the protective film as mixed packaging waste and cardboard boxes along with cardboard dividers as packaging waste made of paper and cardboard.

Cleaning:

Products can be removed mechanically. Residuals can be cleaned with an organic solvent, such as acetone - provided that the solvent does not damage the surface.

Safety instructions:

General health and safety guidelines apply:

- it is forbidden to eat, drink and smoke during work,
- try to avoid contact with skin and eyes,
- wash hands before breaks or at the end of work.
